Town Hall Tree

They are looking for a business(es) to sponsor the volunteer t-shirts. The cost of the sponsorship would be \$1200-\$1400 and would include the WFFF logo on the front and the sponsoring company's logo on the back. He also reported that the deadline for funding requests is June 1. Kay mentioned adding a juried art show to the festival.

Mary reported that in general the retailers were very happy with this weekend's event. The artisan's at Brookside were happy for the most part; only a couple weren't for various reasons.
