Article IV - Board of Directors ; Section 1: Composition of the Board - The current bylaws state that the board is comprised of six members. We propose changing this to be up to twelve members.

Article IV - Board of Directors ; Section 2: Ex-officio Members - The current bylaws state that there can be no more than three ex-officio members. We would like to remove this limit so that we can have members from all the Kearsarge area towns.

Shall the term of the Board be changed to February 1 thru January 31?

Article IV - Board of Directors ; Section 4: Seating of New Officers and Directors - The current bylaws state that the term of the Board is from the first day of the fiscal year (Jan 1) thru the last day of the fiscal year (Dec 31). We usually hold our Annual Meeting and voting of new officers in January. This causes an issue that there is no Board from Jan 1 until the time of the Annual Meeting. This change will resolve this issue.
